INTERFAITH'S FOOD PANTRY IS ONE OF THE LARGEST EMERGENCY FOOD PROGRAMS IN GREATER BOSTON, DISTRIBUTING 700,000+ MEALS TO SOUTH SHORE RESIDENTS EVERY YEAR. THE FOOD PANTRY ALSO OPERATES THE LARGEST FOOD RESCUE PROGRAM ON THE SOUTH SHORE SALVAGING 581,470 POUNDS OF FOOD THIS YEAR FROM LOCAL SUPERMARKETS. FOR 75+ YEARS OUR CLINICIANS HAVE PROVIDED THERAPY AND COUNSELLING SERVICES TO FAMILIES, CHILDREN AND INDIVIDUALS IN NEED. IN 2023, INTERFAITH'S THERAPISTS PROVIDED 3,502 THERAPY SESSIONS TO LOCAL RESIDENTS.
